

## ROPE/HIGH ANGLE RESCUE IV

**Class Description:** Students in this course will be re-introduced to the basic skills or Rope/High Angle Rescue I (RORE), II (RORA), and III. Students will be trained in critical angles as they pertain to single and dual rope highlines, English reeves, and the operations of highlines. Most of the program is hands-on and time is allotted for practice in order to build proficiency.

**Class Prerequisites:** Rope/High Angle Rescue III and be 18 years old.

**Required Gear:** Students will need the following equipment: helmet with chin strap (fire, construction or climbing helmet), eye protection (such as safety glasses, ***HELMET FACE SHIELDS ARE NOT ACCEPTABLE***), clean leather gloves, work or hiking boots which provide support (***NO SNEAKERS***), outdoor work clothing appropriate for weather conditions and water bottle or other suitable device for storing liquids in the field. Students may bring additional personal or department owned equipment, but all such equipment will be subject to inspection prior to use. **FIRE FIGHTER TURN-OUT GEAR IS NOT ACCEPTABLE FOR THIS CLASS.**
